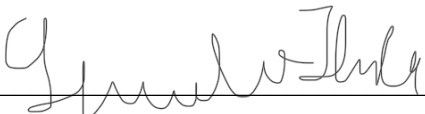
RULES AND REGULATIONS:

Please read carefully and sign.

1. All funerals upon arrival at the cemetery shall be under the supervision of the JACD Board Member or the Board's appointed representative(s).
2. JACD will only accept funeral from Capital District.
3. The JACD will not allow the body of any deceased to be buried without properly filed Death Certificates, Burial-Transit Permit (when applicable), and signed JACC Burial agreement.
4. JACD reserves the right to refuse any ritual that has no basis in the Islamic Sharia before, during, and after burial.
5. JACD reserves the right to refuse permission to anyone to open the coffin or to touch the body of the deceased without the consent of the legal representative of the deceased or without a court order.
6. The entire cemetery is owned and operated by the JACD, having a burial in this property, or signing into a burial agreement with the JACD does not in any way entitle any persons or parties, ownership of the land and or plot,
7. JACD is responsible for grave marking, headstones, and other arrangements regarding the grave such as installation, maintenance, and modifications of grave and surrounding property.
8. JACD disclaims all responsibility for loss or damage beyond its control like damages caused by elements, act of God, common enemy, thieves, vandals, strikers, malicious mischief makers, explosions, unavoidable accidents, invasions, insurrections, riots, or order of military or civil authority, whether damage is direct or collateral.
9. Graves will be identified with an inclined or standing headstone made by a designated supplier of the cemetery. The headstone will only be allowed to have information limited to the name, date of birth and date of death of the deceased in the English language only.
10. JACD has right to add, amend or repeal all or any part of these rules and regulations. from time to time.
11. Embalment of bodies will not be permitted; allowing the body to naturally degrade, without leaving trace chemicals in the soil.
12. Burials will only be allowed between noon and 3 PM during winter months and 1 PM to 4 PM during summer months (off peak hours), seven days a week. Exceptions will only be made for special circumstances (ex: inclement weather expected). If an exception is made, burials will only be allowed during the sunlight hours.
13. Pets or animals of any kinds would not be allowed in the cemetery.
14. No object shall be allowed to be buried along with the deceased. Such as pictures, rings etc.
15. Every attendee, both men and women of the Janazah[funeral] must observe the proper Islamic dressing.
